Corrigendum

Reference: Notification no. 10082/NKDA/BPS-04(7)/2014 dt. 07.11.2023 regarding Revised NOC Fees for issuing NOC for Project within Planning Area [Planning Area is defined in Schedule -I of 'The New Town Planning Area (Building) Rules 2014]

This is to notify that following the 'Schedule of Rates, Taxes, Fees & Charges to be levied by the Corporation during the year 2023- 2024' published by Kolkata Municipal Corporation, the following corrigendum of the notification (Notification no. 10082/NKDA/BPS-04(7)/2014 dt. 07.11.2023) is made with immediate effect.

- NOC Fees will be levied per square meter of built-up area. Definition of 'built up Area', NKDA notification no. 9972/NKDA/Admn (BPS)-415 /11/2009 dt. 02.11.2023 to be followed.
- 2. Fees for Revised NOC with Modified Design Proposal which will Supersede the Previous Proposal (existing Sanction Plan):-

If any revised plan is submitted for the purpose of modification of the existing building plan whose NOC has already been issued earlier by NKDA and where any construction work (any building operation) hasn't been commenced, then for issuance of Revised NOC, the applicant has to pay the amount as per (i) or (ii) whichever is higher: -

- i) The amount of NOC fees as per present rate on submitted revised plan minus the amount paid during initial NOC.
- 25 % of the NOC fees as per present rate on submitted revised plan as would be applicable from time to time.
- 3. Fees for Revised NOC for Internal / External Deviation:-

The application to be made to the Panchayet Samity before / after obtaining Partial / Full Occupancy from the Sanctioning Authority and it shall be done before execution of the internal / external deviation at site.

Fees for Internal deviation which involves deviation from the sanctioned plan within the sanctioned covered space and external deviation from the sanctioned plan which does not infringe any Building Rules, shall be levied as follows;

- (i) Fees for Revised NOC other than Residential, Govt. sponsored Educational Institute & Charitable Buildings is 2 times of the fees as prescribed in the above Table.
 - 4. Process of Issuance of Revised NOC: -

The applicant shall apply for Revised NOC for the projects in the same manner of previously issued NOC. The necessary information of total land area containing list of dag number and parcel of land of each dag number etc. shall be provided.

The applicant may apply for Revised NOC at the following stages -

- i) Where work has not been commenced at site as per NOC issued earlier by NKDA.
- ii) Before execution of Internal Deviation within sanctioned built-up space.
- iii) Before execution of External Deviation beyond the sanctioned built-up space.
- iv) The Revised NOC shall not be applicable for any infringe Building Rules.

The applicant will apply for revised NOC in the format as specified in rule 4. The process of Issuance of Revised NOC will be same as detailed in rule 9 & 9A of The New Town Kolkata Planning Area (Building) Rules, 2014
