

Stacking of Construction Material &



Stacking and Disposal of Construction & Demolition (C&D) Waste and Slurries

Mandates to be followed regarding stacking of construction material and stacking and disposal of construction demolition

(C&D) waste and slurries: -

Do's

- 1. Submit a scientific Construction Management Plan to NKDA while applying for Sanction of Building Plan.
- 2. Keep a set of sanctioned drawings at site during construction.
- 3. Display sanctioned drawings (preferably elevation) and name and contact number of applicant supervising Architect and Engineer and contractor/site—in- charge in standard display board (min. size of board—1000mm x 600mm).
- 4. Wrap the construction area / building(s) at the time of construction to avoid pollution as well as disturbance to the neighbors.
- 5. Wrap the construction material properly during transportation to prevent air pollution and for safety.
- 6. Use construction power for construction purpose instead of using D.G set. This is to be strictly adhered to.
- 7. Maintain proper safety measures for the life of construction workers and for surrounding residents / pedestrians during construction.
- 8. Provide bio- toilet / proper toilet facility (temporary) for the construction workers.
- 9. Properly stack and wrap construction material so that it does not damage the abutting road / service lines. If any damage occurs, the owner is bound to compensate.
- 10. Keep C&D waste and slurries within the respective site till disposal.
- 11. NKDA paid service may be availed (if required) for disposal of C&D waste.
- 12. If item. no. 9 is not complied, OC/POC will not be obtained by the owner / applicant.
- 13. Submit photographs of site and its surroundings alongwith the application for OC/POC.
- 14. Follow provisions in The New Town Kolkata (Building) Rules 2009 during construction.

Don't

- Do not dump C&D waste in the service manhole / gully pit of sewerage and drainage.
- 2. Do not stack/ store construction material on the carriage way of any road / street.
- Do not damage adjacent footpath, road, drain, sewer line, underground OFC, electrical line due to construction activities or by dumping C&D waste and sluries.
- 4. Do not dump C&D waste in common public places (viz. parks, playgrounds, greenery, footpath, service roads etc.) or vacant plot.
- 5. Do not create any nuisance by the construction workers / construction activities.
