(c) Source Reduction Volunteer (SRV)	18

Person having the following qualifications and interested in social work, may apply.

Qualification, Terms and Conditions:-

1. Minimum Qualification for Supervisor: Higher Secondary passed from any recognized Board / Council.
2. Minimum Qualification for Surveyor: Madhyamik passed from recognized Board/ Council.
3. Candidate shall have inclination in social activities.
4. Honorarium for surveyors: Rs. 150/- per day for enumerating more or less 60 homes (Maximum 10 days in a month).
5. Honorarium for supervisors: Rs. 150/- per day (Maximum 10 days in a month).
6. Honorarium for Source Reduction Volunteer: Rs. 150/- per day for vector control work (Maximum 15 days in a month).
7. Candidates must be resident of New Town or adjacent area of New Town.
8. Age: Not less than 18 years and not more than 50 years.
9. The volunteers may be required for this calendar year i.e. up to December, 2018. However, the requirement may end at any point of time before that.
10. New Town Kolkata Development Authority may at any time terminate the engagement of any volunteer without showing any reason.

11. Engagement / functioning as volunteer shall not create any right of employment in future in any form whatsoever.
12. Mere filing / submission of application shall not create any right for engagement as a volunteer.

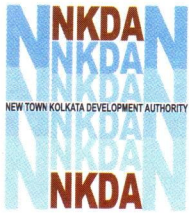
